# Changes at the APACPH Directorate

The Directorate Office will be ceasing its operations from Monash University from 2010 onwards. Monash University has been hosting the APACPH Directorate Office since 2007 under the leadership of Prof Brian Oldenburg who will still remain as the APACPH Representative from Monash University as well as the Regional Director for the Australian Regional Office.

The Executive Board is currently reviewing options of relocating the Directorate Office or to find other ways to carry out the functions of the Directorate Office.

The APACPH Executive Officer, Mr Desmond Gul, will also be finishing up his time with APACPH by the end of June. He will be taking up a new position as Research Administrator for the Centre of Microbial Genomics at Monash University. Ms Emma Frean who has recently joined Monash University will be taking over the role of Executive Officer for APACPH during this time till the end of the year.

## World Health Day Forum at Monash

Alfred Medical Research and Education Precinct (AMREP) Global Health Forum, World Health Day 2009 (prepared by Emma Frean)

'Global Health and Global Crises' was the theme of the 3rd Annual AMREP Global Health Forum which took place on World Health Day in Melbourne on 7 April 2009. Significant contributions in organizing the Forum were made by AMREP partners, including Monash University, the Burnet Institute, Baker IDI Heart and Diabetes Institute and The Alfred Hospital. Over 250 participants, from South Africa, China, Indonesia, Fiji, New Zealand and Australia participated in the event to exchange ideas and discuss the ways in which the global financial crisis and its subsequent economic impact on all countries will affect the future health and well-being of citizens from developing nations.

The Forum brought together both international and local researchers, among them representatives from Oxford University, the Papua New Guinea Institute of Medical Research and the Fiji School of Medicine, as well as professionals from the World Bank and AusAID. There was also considerable representation from the NGO community, with representatives from World Vision, Médecins Sans Frontières and Plan International. Up to one third of participants were students from various disciplines, with a significant presence by Ignite, a student-lead organisation functioning out of Monash University with a focus on global health improvement. The group coordinated a photographic exhibition of images relevant to the theme of the Forum and attendees were asked to nominate the best image. The winning photo was submitted by Daniel Mason, entitled 'Mother and Child'.

Keynote speakers included **Professor Dan Ncayiyana**, Editor, South African Medical Journal, who gave an informative presentation on the challenges of access, equity and quality confronting health and health systems in sub-Saharan Africa. He highlighted the role played by poverty and poor governance in South Africa's failure to achieve better provision of health services in the fifteen years of post-apartheid democracy. **Professor Mark McGillivray**, Chief Economist at AusAlD, similarly discussed health inequality and increasing deprivation in developing countries, with particular reference to the current financial climate. The greatest challenge to improving global well-being lies in restoring the health-income nexus for low health countries through positive global income growth.

The changing nature of the international health operating environment, known as 'global health architecture', was discussed by **Ms Susan Ivatts**, Director of the Health & HIV Thematic Group (AusAID), who highlighted the proliferation of organisations, initiatives and partnerships to address declining health status in low and middle income countries. The current work by the High Level Taskforce on Innovative International Financing for Health Systems shows a need to strengthen countries' capacity to take ownership of projects, along with a need to build better relationships between actors, particularly those with civil society.

Further to the theme of the global financial crisis and aid financing was that of the global food crisis and the state of nutrition and health of developing countries. Resulting from an increase in demand and higher energy prices, global food prices rose by 83% over 2007-08 financial year. This pushed 100 million people below the 'dollar-a-day' poverty line and forced low income groups to switch to nutritionally-poor foods. Speakers identified a need for a greater focus on food-based nutrition, largely through agricultural capacity building, as trialled in the Millennium Villages Project in Africa.

## Swaziland Mission by Taipei Medical University

**Prof Wen-Ta Chiu** in his capacity as President of **Taipei Medical University**, had just returned from the **Kingdom of Swaziland** for an inspective tour of Taiwan Medical Mission which is executed by Taipei Medical University.

The Guidelines of this Mission are as follows:

- 1. To provide long-stay medical service in Swaziland;
- 2. To provide professional medical training and know-how transfer programs from Taiwan;
- 3. To assist hospital management in Swaziland;
- 4. To execute hygiene and nutrition plan for children;
- 5. To provide mobile medical services

Since April last year, the team of 9 Taiwanese doctors and health professionals stationed at the Mbabane General Hospital has performed numerous brain, spina, abdominal and orthopaedic surgeries as well as worked with the local surgeons in cancer surgery. The team also worked with the local people to improve the health of the people of Swaziland.

Apart from visiting this medical team in Mbabane General Hospital, Prof Wen-Ta Chiu participated in the celebration event of His Majesty, **King Mswaiti III**'s birthday and met with the Prime Minister, **Dr. Dlamini** for further cooperation.

### What is the cost?

The cost for the course itself is free. Howver, participants are expected to pay **US\$200** per person towards the accommodation, meals and field trips/tours over the course period. Participants are responsible for all of their travel expenses and incidentals such as laundry, personal phone calls, faxes, internet or email usage, and shipping of personal items from the course. There will be tours which will be co-ordinated by course organizers to key locations such as Health Promotion department and Anti-tobacco campaign offices in Manila (TBA)

Participants are encouraged to secure financial aid from their Ministries of Health, WHO and universities. Please note that entry into Philippines requires a Visa only if you wish to stay longer than 21 days.

## Healthcare in South-East Asia Economic Crisis

### Healthcare in the midst of economic crisis in South East Asia - Much needs to be done to mitigate its impact in the region

#### Introduction



World economy has presently entered into severe economic depression after the 1930s. Its effect is increasingly evident in many countries in different magnitudes. The challenge facing the world now is to prevent an economic crisis becoming a social and health problem. Countries at all levels of development are concerned about the impact of the economic crisis on health. Coming hard on the heels of food and fuel crisis of 2008, this is likely to be a serious set back in the fight against poverty and achieving the target of poverty-alleviation in fulfilling the obligations of Millennium Development Goals. Decline in healthcare spending coupled with

increased cost of treatment, reduced family income and insurance coverage will affect the utilisation of health services and their quality. The most common effect will result in decline of demand for private healthcare with consequent transfer of demand to the public sector. If public health services are compromised and not adequately equipped to cope with, the overall quality may deteriorate. This problem will affect all countries in which public-funded services are under pressure.

#### Impact of economic crisis on healthcare: Evidence from Asia

Experience from Asia shows that due to rise in food prices last year, about 100 million people were pushed into poverty alone and a number of children suffered the condition of under-nutrition. The 1997-1998 crises did indicate a fall in immunisation rates and under utilisation of primary health services especially, among the poor. The period also witnessed a fall in private healthcare spending across the region and showed a greater reliance on public health spending, government commitment



towards health, and comprehensive strategy for universal coverage particularly in Thailand. The shortfall and consequent increase in the prices of drugs were also noticed and a significant decline in donor contributions towards health projects was experienced in most of the Asian countries.

### Strategies to mitigate the impact of economic crisis on health

Despite financial crisis and consequent fall of revenue generation, unemployment and decreased income level, health should be given utmost visibility. Health is an entitlement to which people have basic right. Good health makes significant contribution to economic growth, poverty reduction, social development and human security. The health response should aim at transforming the quality of life and should be used to promote a greater focus on social and developmental justice. Some countries will be more vulnerable to the impact of economic crisis than others. It is therefore very important, to take into account the need of vulnerable populations – particularly the poorest of the poor – wherever they may live.

The magnitude of the current crisis with its wide ramification will make the policy makers to be more vigilant for long-term plans on various issues of healthcare. Looking to various intricacies of the present crisis world wide, innovative strategies like partnerships and collaboration between and within countries will be crucial. Rapid monitoring and analysis, effective communication, exchange of experience, flexible working arrangements and evidence based research will be all essential to mitigate the impact on healthcare and achieve success. Additionally, the five-point framework (Fig. 1) by the WHO to ensure the health sector emerges from the crisis in good condition should be kept in mind for action.

The present economic crisis has posed challenges to healthcare and the natural right of every human being to enjoy the highest attainable standard of health. On the other hand, the crisis has also offered opportunities to lay foundations for more equitable and effective health systems for the future. This will rationalise and pave the way for good health and prosperity of the people throughout the world. Hence, solidarity, standing by commitments and keeping promises to support each other will be the need of the hour.
