Public Health in Higher Education: Plans for a Healthier Asia Pacific Rim

Public health awareness and improved health care service are growing priorities for communities around the world, and the Asia Pacific region is no exception. Globalization continues to change the landscape of international relations, commerce, and travel. As members of more regions come into contact with one another, new public health challenges will inevitably arise. As such, public health officials are seeking ways to be better prepared for the unknown, and to educate citizens about health behaviors that will decrease new incidences of chronic disease. The countries of the Asia Pacific region can begin collaborating to improve the region's public health by using a powerful tool: education. Broadening the reach of public health, epidemiology, and global health education to the undergraduate level will be great progress toward a shared vision of health and wellness. A new generation of citizens will have expanded knowledge of health issues and practices. Many among them will become educators, public health workers, and government officials who can change the way public health service and education is thought about and delivered throughout the Asia Pacific region.

Members of APACPH who participate in several other public health education networks have been a part of planning and implementation efforts to create undergraduate public health education curricula in the United States. Based on the initial success of such efforts in the U.S., organizations are working to expand the undergraduate education efforts worldwide. Because APACPH membership draws such a wide array of highly competent and motivated individuals from a variety of influential organizations and institutions, collaborating to implement a cutting edge idea seems the natural next step to take.

The Asia Pacific region needs more public health workers for the demands of its immense population. Currently, there are not enough individuals who have earned MPH degrees to provide for the public health workload of the region. The potential exists for significant improvement in the public health and health education workforce. If bachelor's programs or certificate programs in public health, epidemiology, and health promotion and education became available to students, many could join the workforce upon graduation and alleviate issues caused by an insufficient number of qualified employees for the needs of the region.

Beyond merely preparing public health workers, however, implementing undergraduate public health education serves a far more practical purpose. By making a public health class a general requirement for those pursuing bachelor's degrees at universities throughout the region, the level of knowledge about health issues, health-promoting behaviors, and health risks of the population at large will immediately improve. The study of public health and epidemiology at the undergraduate level will grant students an understanding of the most basic public health concepts. Even if these students go on to industries other than public health, they will still be armed with the new knowledge that will hopefully influence their patterns of health behavior.

The capacity to create a network of undergraduate public health programming in the Asia Pacific region exists. It is now up to APACPH to create the infrastructure to do so successfully, and to guide the programming implementation in a manner that will be of the most benefit to all involved. Public health, after all, is a matter of global importance. The Roundtable Interactive Discussion at the Conference is designed to allow for brainstorming, and the initial phases of planning the vision of undergraduate public health education in the region. Together APACPH can educate and prepare leaders to grow and advance the field so that all may gain from the organization's teamwork.

University of Colombo Student Attachment in Melbourne

3 medical students from the University of Colombo, Sri Lanka were at Monash University recently (24 September - 12 October) on a 3 week elective programme to learn more about public health as part of the medical education. They were guided by Prof Brian Oldenburg and Academic Mentor Dr Stephen Bunker from the Department of Epidemiology and Preventive Medicine at Monash University. While at Monash, they interacted with various researchers, staff members and students and visited a number of public heatlh care organisations and centres. Their topic of work while in Australia was "Prevention and management of chronic disease (eg. diabetes and heart disease): Lessons learned from Australia for Sri Lanka". Below is their story:

Elective at Monash: An experience of a lifetime.

Elective, we knew was going to be one of the highlights of our medical career and today as we approach the end of our elective appointment we are delighted to say that, indeed it was. Discussions on what we wanted to do and where we wanted to go to do our elective started almost one year back when we had our first ever glimpse into international public health at the 38 th APACPH conference in Bangkok, Thailand. While exploring our opportunities we were stunned to hear from Prof. Brian Oldenburg inviting us to do our elective under his guidance at the Department of Epidemiology and Preventive Medicine at Monash University, Australia. We could not have asked for anything better, to do our elective in a world renowned University situated in one of the most developed countries in the world. This is our story.....

Apart from the cold weather, the first thing that we noticed when we landed in Australia was its friendly, cheerful people who were extremely helpful. Throughout our stay we met many people from different institutes, different parts of the country, and people who have specialised in various public health specialities but no matter how famous they are or how qualified they, are all of them had the time to say hi, and offer their help.

Everything was new to us, and everyday was a whole new experience teaching us something brand new. The places we visit, the people we met, and everything else that Mother Nature had to offer down under was a blessing because we had only 3 weeks to experience it all.

The best experience for us was to get to know how things are done in a high-resource country where resources are plentiful and the need for compromise is minimal. We had the opportunity to experience many chronic disease prevention strategies practiced in Australia that are alien to us. Even though they cannot be directly applied to a low resource Sri Lankan context, the ideas behind the strategies were innovative and simple and that enabled us to always analyse these strategies with the idea of modifying them to suit our country.

Everything we learned and everything we did during the last 3 weeks will be an inspiration to us in all our future endeavours and more than anything this will give us the capacity to make a difference (if the opportunity is given) for the betterment of Sri Lanka.

Finally we would like to say a big thank you to all the people at the Department of Epidemiology and Preventive Medicine who helped us make this dream a reality. Prof. Brian, Dr. Steve, and Desmond thank you so much for going out of your way to make time for us in your busy schedules and to guide us during the course of our attachment.

American Public Health Association Grant Award Program

American Public Health Association - International Health Section Award Program, sponsored by Colgate-Palmolive

Community-Based Field Research Grants to Young Faculty and Students at Schools of Public Health for Behavioral Hygiene Promotion and Global Health

The International Health Section of APHA in collaboration with Colgate Palmolive is pleased to announce the third round of a small grants program to support young faculty and students in schools of public health or tertiary institutions with an established public health program to carry out community-based field research in behavioral hygiene. These competitive grants will be awarded for community-based research projects investigating the role of hygiene (especially hand washing with soap) in personal and community health and infection control, including investigations about the knowledge of proper hygiene habits, hygiene motivation and behavior change. The research should focus on mothers, families and children in resource-poor settings. Each award will be in the range of \$10,000 - \$15,000. A total of \$30,000 is available to support this initiative each year.

Awards will be made on the basis of merit as determined on independent review by 5 senior reviewers. Three awards will be made, with preference being given to projects to be carried out in one the following countries: Puerto Rico, Mexico, Colombia, Guatemala, Honduras, Nicaragua, Costa Rica, Panama, Thailand, Malaysia, South Africa, Senegal, Kenya, Mozambique, or the United States. The U.S. investigation would need to focus on migrant or immigrant populations. Awards will be made through schools of public health or tertiary institutions with an established public health program. The institution concerned can be based in the United States or in another country as long as the field research is carried out in one of the above countries or another developing country, if the proposal is of superior merit. Those projects which are funded will be presented and/or recognized at the annual meeting of APHA at the World Federation of Public Health meeting there.

APHA, working in collaboration with the Working Group on Community- Based Primary Health Care of the International Health Section, will take responsibility for administering the program. This round of the competition is formally announced with this notice. The deadline for the submission of proposals is 17 November 2007, with funded projects beginning on 1 February 2008.

APACPH Announces Mini-Grant Program

APACPH Announces a Mini-Grant Program to Support Research and Training

APACPH will be requesting proposals for mini-grants to stimulate innovative research and training projects. Awards will range from US\$1000 to support student dissertations to up to US\$5,000 for research projects and training and capacity building activities. Preference will be given to proposals with lead investigators from low and middle developing nations and those that are interdisciplinary and involve multiple APACPH institutions. Grantees will have up to 12 months to complete the funded projects with possibility of a six month extension. All grantees will be expected to submit an abstract based on project findings for the next APACPH conference, utilize data to the extent possible to seed additional grants, and publish their findings.

Application forms and detailed instructions will be made available on the APACPH website soon.

Further details will be announced during the General Assembly meeting at the Tokyo conference.

Admiral Jerrold M Micahel Fellowship in Public Health Education

The founding Dean of the Asia Pacific Academic Consortium for Public Health, **Dr Jerrold M. Michael**, has been honored by the establishment of a Fellowship in his name dedicated to the graduate education in public health for career officers in the United States Public Health Service. The Fellowship has been established by the **Public Health Service Commissioned Officer Foundation for the Advancement of Public Health**, located in Washington, DC.

Before beginning his 36 year career as a public health academic, Dr. Michael served for 20 years in the Federal career service of the United States, attaining the post of Assistant Surgeon General of the United States with the rank of Rear Admiral. He subsequently served for 25 years on the faculty of The School of Public Health at the University of Hawaii, the majority of that time as its Dean. He later retired from that post and for the past eleven years has been an Adjunct Professor of Global Health at the George Washington University School of Public Health and Health Services, in Washington, DC.

In the announcing the **Admiral Jerrold M. Michael Fellowship**, the Foundation noted that "This was an appropriate manner to celebrate Professor Michael's long and distinguished career as an advocate for advanced public health education to better serve the global community."

Public Health Law Series 2007 at CUHK

The **School of Public Health** and the **School of Law** at **The Chinese University of Hong Kong (CUHK)** will be jointly organising a series in public health law from October to November 2007. The series has three main parts:

1. Short Course in Public Health Law Dates: 27 October - 19 November

In this public health law certificate course, participants will learn about the role of lawyers and the law in the public health arena. They will look at how the law regulates public health, how the government can apply public health interventions, and how the global community can influence public health worldwide.

2. The School of Public Health Annual Symposium: The Law and the Public's Health: Current Challenges Date: 17 November, 2-5pm

International speakers including Prof. Lawrence O Gostin, Faculty Director of the O'Neill Institute for National and Global Health Law of the Georgetown University Law Center and others from the UK, Australia, and Hong Kong will be giving presentations on current issues concerning the law and public health.

3. The First Public Health Genetic Foundation Annual Lecture in Hong Kong Date: 19 November, 6.30-8.30pm

Prof. Lawrence O Gostin from Georgetown University, USA, has been invited to speak at this Open Lecture, which is coorganised by the CUHK School of Public Health and the Department of Community Medicine at The University of Hong Kong.

Short Courses Offered by APACPH Members

CUHK School of Public Health is pleased to offer two short courses in health economics which will be given by senior staff members of the **Health Economics Research Centre** at the **University of Oxford**. The details of the courses are as follows:

1. Introduction to Health Economic Evaluation

This one-day introductory course will lay down solid foundations in evaluating health care interventions from an economic perspective. It will start by establishing basic health economic concepts, move on to the measurement of costs and outcomes, and finish with the application of cost-effective analyses in decision-making. The course is particularly suitable for health care managers, researchers, pharmaceutical and medical technology industries. Participants are not required to have a previous knowledge of economics.

2. Advanced Methods of Cost-Effectiveness Analysis

This is a hands-on, computer-based course that will run over three days, and will involve exercises and individual tutoring as well as lectures. It aims to instruct participants in practical health economic evaluation, and will include modules on decision analysis, cost analysis, and the analysis of health outcomes. The training will be ideal for health service managers, health economists and health sector researchers. While participants will need to know the basic methodologies for economic evaluation, and be familiar with Excel, prior experience in using the decision analysis software is not required.
